What are the reasons for your objection?

This Development fails to respect either the existing Design and Development Overlay or the Preferred height under the proposed Overlay under the City North Amendment.

- At 16 levels above ground, this represents a 100% increase over the recommended height under the existing DDO.
- At 57.7 metres to the Lift over-run, the height of the proposed tower exceeds the preferred height under City North [of 40 metres] by 44%.

The tower component of the new development is not a respectful addition to the retained heritage fabric.

- According to the Architect's Statement ... the horizontal language of the tower contrasts with the vertically emphasised engaged piers of the heritage façade.
- In our view this treatment constitutes a striking architectural response that will completely dominate an acknowledged heritage asset. This is not a respectful outcome.
