Dear all

The Minister for Planning has signed a notice of decision to grant a permit to the Becton plan for 547 units on the Eastern Precinct. The only modifications to the submitted plans are a small portion of the southern section of the 11 storey building on Swanston Street has been reduced by two storeys, with an addition of a 7th level to the eastern wing parallel to Cardigan Street. As well a section of the southern section of a six storey building parallel to Cardigan Street will be reduced by two floors with a compensating extension of the buildings to the south. A small reduction of one floor is required for part of the building on the corner of Faraday and Swanston Street. Essentially the conditions match the Melbourne City Council recommendations in relation to the scale and bulk of the complex. At this stage, although there no final elevation plans are available for the buildings. In lieu, copies of the unendorsed elevations that are the working plans are attached. Our Committee and Planning Group remain of the view that the resulting plans would still be visually bulky and out of scale with the character of buildings in the area and contrary to planning controls. We are negotiating with Becton Corporation and have also lodged an Appeal to VCAT against the decision. If we can achieve a negotiated settlement we will withdraw as an objector.

Our next General Meeting will be on Tuesday 15th June from 6 to 7.30pm in the Kathleen Syme Building (former Faraday St school). Our speakers on "Creating Public Spaces including Trams" will be Hubert Guyot, CEO of Yarra Trams, Rob Adams, Director, MCC City Projects, Arts & Culture Division, and Professor Kim Dovey, University of Melbourne. Note that the meeting date differs from the listed date due to the availability of the speakers. Straight after the meeting, there will be the CRA Planning Group Meeting at 7.30pm.
