The subject property no.435, is one terrace house in a row of three. The other two, nos.437 & 439, are already being used for student accommodation, the operation of which, is subject to a Section 173 Agreement relating to site management.						
Carlton Residents Association does not object to no.435 being used for student accommodation, providing that the permit issued is also conditional upon an adequate site management plan.						
Carlton Residents Association believes that, the increased accommodation due to the addition of no.345, warrants strengthening of the existing Section 173 conditions, by including the requirement that a manager or caretaker be present on the site at all times.
